

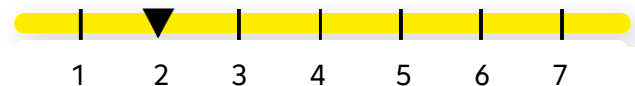
RAIFFEISEN EURO PREMIUM SHORT BOND FUND

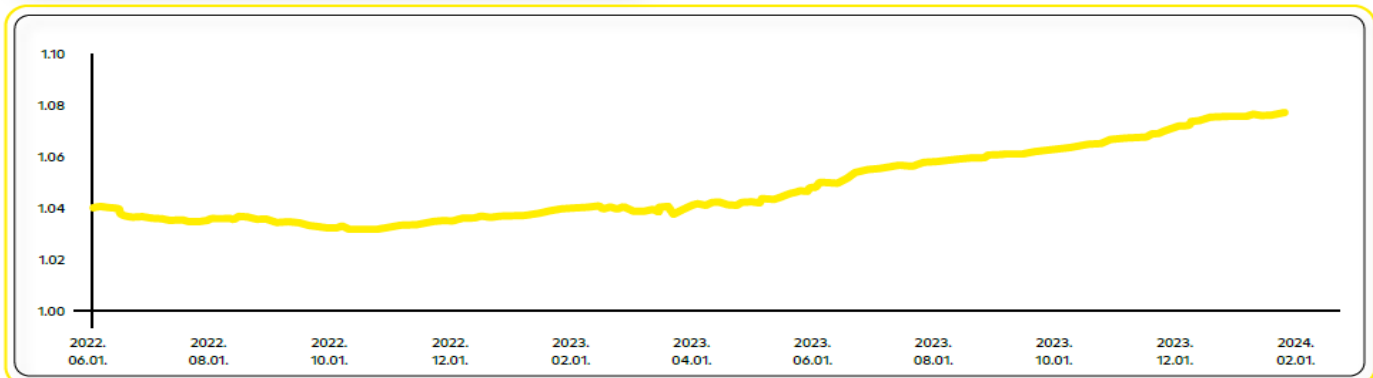


KIID risk level (SRRI)

SHARE CLASS 'A' (EUR)



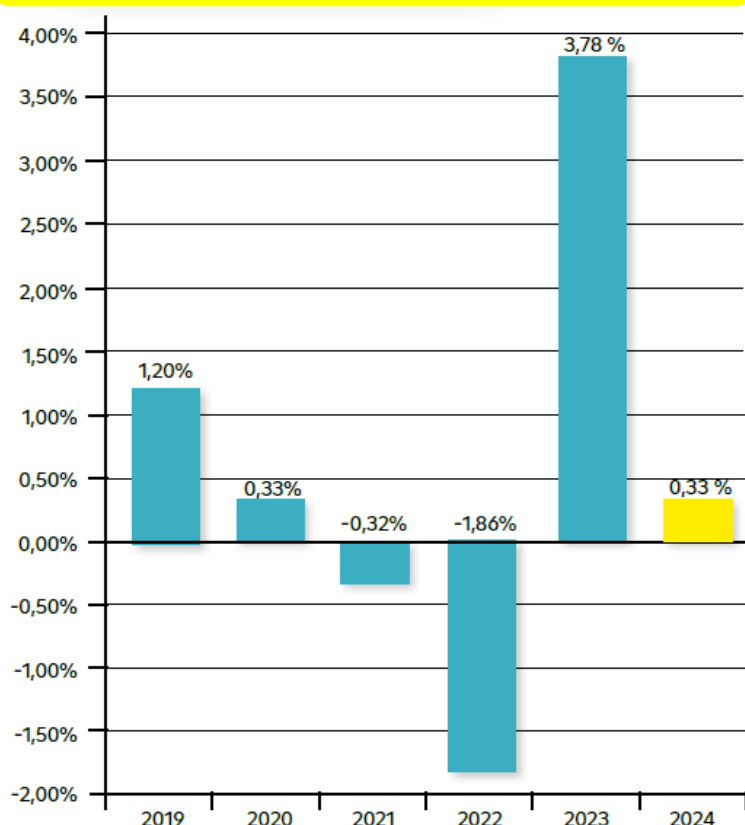

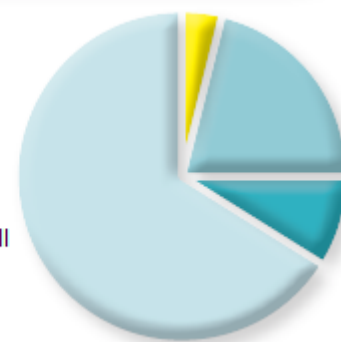
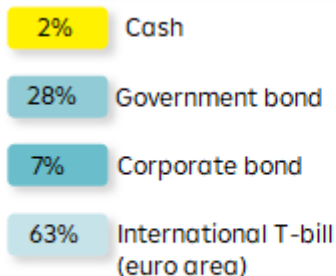


RETURNS FOR THE LAST 5 YEARS AND THE CURRENT YEAR "A" SERIES EUR
